THE CENTER HAS BRIDGE GAMES SEVEN DAYS PER WEEK WITH 14 SCHEDULED GAMES. OPEN HOURS GIVE BRIDGE STUDENTS THE OPPORTUNITY TO SHADOW BRIDGE PLAYERS, PLAY BRIDGE, AND FURTHER DEVELOP SKILLS. THE ACTIVITY FOR THIS CALENDAR YEAR INCLUDED 5,251 TOTAL TABLES. EXPENSES INCLUDE BRIDGE SUPPLIES AND EQUIPMENT, ACBL FEES, GAME DIRECTOR FEES AND OTHER BRIDGE COSTS.
